Comments included views on the current arrangements, historic responsibilities, and general dissatisfaction with the situation. A previous Chair and long-standing village resident with historic involvement in the village hall also quoted from previous minutes about the history of the hall and how it came about and how the management had developed over time. There was a casual request for more information around the property deeds and the constitution which will be attended to.

There is concern that the stagnation of the site and buildings are having a detrimental effect on the parish and many of its residents.
